 2 days off at Easter break not charged to vacation or sick leave days.
 - o Superintendent is allowed to drive own vehicle when weather is inclement with reimbursement.
 - o Family insurance will be provided unless spouse has other health insurance.
 - Kayleen Peters made a motion to offer Martha Potter a three year contract, with the 1st preference of compensation which is \$77,552.60 the first year following the calculation of = [(\$75,000.00+650.00)x1%] x1.5%. The second year will be \$78,984.63 following the calculation of $=(\$77.552.60+650.00)\times1\%$. The \\$650.00 number depends on the base increase of teacher negotiations. The third year will be \$80,430.98 following the calculation of =(\\$78,984.63+650.00)x 1%. The \$650.00 number depends on the base increase of teacher negotiations. The contract is to include the additional holiday days of four days at Christmas break and two days at Easter break. The wording that the Superintendent is required to live in superintendent housing will be added. The Superintendent will be allowed to get travel reimbursement for driving her own vehicle when the weather is inclement. Family insurance will be paid for Superintendent unless spouse has other health insurance. Brandon Ler seconded the motion. Shawn, Kayleen, Lance, and Brandon voted yes and the motion carried.
